Sub: Issue of Certificate of Recognition to the Schools under sub-rule (4) of rule 13 of the Odisha Right of Children to Free and Compulsory Education Rules, 2010 and under Section 18 of Right of Children to Free and Compulsory Education Act, 2009

Dear Sir / Madam,

With reference to your online application no. 11815/2018 and subsequent correspondence with the school / inspection in this regard, I convey the grant for issuance of Certificate of Recognition to the DAV Public School, MCL, IB Valley Area, Brajrajnagar (name of the school with address) for Class primary to Class VIII for a period of five years w.e.d. dt. 04.04.2018 to dt. 31.03.2023

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not extendable and does not in any way, imply any obligation to the respective affiliate board / society.
2. The School shall adhere by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Odisha Right of Children to Free and Compulsory Education Rules, 2010.
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary / upper primary till as long as facilities are provided, further that in case of primary classes also, this provision shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society / School shall not collect any capitation fee and subject the child of his or her parents or guardians to any other form of payment.
6. The School shall not deny admission to any child belonging to any group, if such admission is sought in accordance with the provisions of the Act and the Rules thereunder.

In the pursuit of regularity, certain conditions shall be as follows:-

The School shall ensure:-

- (a) No child admitted in any class / section / class / classroom expelled from school till the completion of the school / section / class / classroom.
- (b) No child shall be admitted in any class / section / class / classroom if such admission is sought in accordance with the provisions of the Act and the Rules thereunder.
- (c) Every child completing elementary education shall be awarded a certificate as and when under Item 22.
- (d) Inclusion of SSI (students with disabilities) / special needs as per provision of the Act.
- (e) The school shall ensure that the minimum number of teachers as per Section 24(1) of the Act is maintained.
